As I convey my facilitation to this gathering, I fondly remember when Bhutan had the opportunity to host the SATRC workshop on spectrum in 2016 to discuss and agree on the implementation plan for the SATRC Action plan phase V. I felt that the workshop has enabled us to discuss our common position and issues related to spectrum usage for mobile broadband, spectrum reframing, non-ionizing radiation safety in the frequency bands used for mobile phones, and spectrum sharing. Likewise, we also had the opportunity to host the 15th SATRC in 2014, which in itself had led to greater awareness on the ICT/Telecom regulatory requirements amongst the leadership of Bhutan.



As all of you meet for the 23rd SATRC meeting in Tehran, I feel that it is an opportune time for all of us to reflect on our roles. With the rapid development in the ICT/Telecommunication sector, our role as the regulator has now become more critical than ever. With the emergence of Internet of Things, Artificial Intelligence, metaverse, among others, the need to facilitate as well as regulate these technologies for the socio-economic development of the country now needs our strategic interventions. As our world now becomes more interconnected and interdependent, we can work as a team to tackle all these emerging technologies. Most importantly, as the role of the SATRC becomes more important and complex, Bhutan would like to assure of our continued support to the SARTC. The Ministry of Information and Communications of Bhutan remains committed to support all the work done by BICMA and through them by the SARTC.

Lastly, let me once again congratulate the SARTC on your silver jubilee and the APT for creating this great platform.
